### Law

We're writing as the Law Tutors at St Hilda's to welcome you to read for a BA degree in Jurisprudence. We look forward to meeting you in October and hope that you will enjoy your time at Oxford.

To help you prepare for your course, the Law Faculty has prepared an Induction Course Pack (attached to this letter and which will also be sent by the Law Faculty) which provides you with an introduction, as well as both a statute and a case exercise to complete. Please work through this carefully. It should lead you to begin to think about how we analyse statutes and cases, and we will discuss these exercises together in your first week at Oxford. It is probably better not to do these too far in advance of coming up, so that they are fresh in your mind when you arrive.

We also enclose a list of books that you might find useful should you want to do some reading before you come up to Oxford. At this stage, there is no need for detailed knowledge of the subjects, but merely a general sense of how the different dimensions fit together, so you should not expect to take very many notes as you work through these texts.

Please note that this is not a prescribed reading list; rather it gives you a selection from which you might want to read two or three books which appeal to you, so that you get an idea of what Law is about. You will, however, probably find it helpful in your first term to have read some of the substantive textbooks on the list. Reading a good quality newspaper will also heighten your awareness of contemporary legal issues. We do not recommend that you purchase these books. You might be able to get hold of a copy in your local library or a local University library.
