

University of Oxford Outreach and Your Data

In the course of completing this registration form, you have provided information about yourself ('personal data'). We (St Hilda's College) are the 'data controller' for this information, which means we decide how to use it and are responsible for looking after it in accordance with the General Data Protection Regulation and associated data protection legislation.

How we use your data

We will use your data to register you as a participant in the outreach event you are attending/have attended. Using your data in this way is necessary for a task that we carry out in the public interest (i.e. running events to promote access to Higher Education) and to meet our legitimate interests in promoting applications to the University.

We will only use your data for the purposes for which we collect it, unless we reasonably consider that we need to use it for another related reason and that reason in compatible with the original purpose. If we need to use your data for an unrelated purpose we will seek your consent to use it for that purpose.

Who has access to your data?

Access to your data within the University will be provided to those who need to view it as part of their work in carrying out the purposes described above. Access will also be provided to any third parties that we use to help organise the outreach event you are attending/have attended. Where we share your data with a third party, we will seek to share the minimum amount necessary.

We will add some of your data to the Higher Education Access Tracker database (HEAT <u>www.heat.ac.uk</u>), which we use to record information about our outreach activities and those who take part in them. HEAT is a shared database used by a variety of organisations to identify which activities are most helpful in preparing students for higher education and progressing to employment. Users include the University, its colleges, student organisations, educational charities and relevant public bodies (e.g. UCAS). The data added to HEAT comprises your personal data (name, gender, ethnicity, date of birth, postcode, and school) as well as parental attendance at higher education, eligibility for Free School Meals, care or care leaver status and the events or activities in which you have participated. You can find further details about how your information is used on HEAT by emailing the Outreach Officer at St Hilda's College.

Retaining your data

We will only retain your data for as long as we need it to meet our purposes, including any relating to legal accounting, or reporting requirements.

Where we store and use your data

We store and use your data on University premises, in both manual and electronic form.



Your rights

Under certain circumstances, by law you have the right to:

- Request access to your data (commonly known as a "subject access request"). This enables you to receive a copy of your data and to check that we are lawfully processing it.
- Request correction of your data. This enables you to ask us to correct any incomplete or inaccurate information we hold about you.
- Request erasure of your data. This enables you to ask us to delete or remove your data under certain circumstances, for example, if you consider that there is no good reason for us continuing to process it. You also have the right to ask us to delete of remove your data where you have exercised your right to object to processing (see below).
- Object to processing of your data where we are relying on our legitimate interests (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground. You also have the right to object where we are processing your data for any direct marketing purposes.
- Request the restriction of processing of your data. This enables you to ask us to suspend the processing of your data, for example, if you want us to establish its accuracy or the reason for processing it.
- Request the transfer of your data to another party.

Depending on the circumstances and the nature of your request it may not be possible for us to do what you have asked, for example, where there is a statutory or contractual requirement for us to process your data and it would not be possible to fulfil our legal obligations if were to stop. Further information on your rights is available from the Information Commissioner's Office (ICO).

If you want to exercise any of the rights described above or are dissatisfied with the way we have used your information, you should contact the University's Information Compliance Team at <u>data.protection@admin.ox.ac.uk</u>. The same email address may be used to contact the University's Data Protection Officer. We will seek to deal with your request without undue delay, and in any event in accordance with the requirements of the GDPR. Please note that we may keep a record of your communications to help us resolve any issues which you raise. If you remain dissatisfied, you have the right to lodge a complaint with the ICO at <u>https://ico.org.uk/concerns/</u>.
